Awards for Best Exhibit in Each Section.

SECTION 1 FLORAL ART

Classes 1 and 2 maximum width 60 cm/ 24 inches

- Class 1. "A Christmas Carol" an exhibit, accessories allowed, FPM, name of carol to be stipulated.
- Class 2. "Boxing Day Woodland Walk" an exhibit, no accessories, NPM.

Classes 3 and 4 maximum width 25 cm/ 10 inches

- Class 3. "All thar Glitters" an exhibit in a candlestick, accessories allowed, may include APM.
- Class 4. "Christmas Cheers" MEN ONLY, an exhibit in a tankard, accessories allowed, may include APM.

FPM – Fresh plant material, NPM – natural plant material, APM – artificial plant material.

SECTION 2 HORTICULTURE

- Class 5. 3 stems of flowering/fruiting ornamental trees and/or shrubs including seed heads.
- Class 6. A pot plant for foliage
- Class 7. A flowering pot plant
- Class 8. 2 Parsnips
- Class 9. 2 Leeks
- Class 10. 2 Onions
- Class 11. Pair of any other vegetables not listed above
- Class 12. One specimen flower or seed head and one specimen vegetable.

SECTION 3 COOKERY

All exhibits must be homemade and covered with cling film.

- Class 13. Decorated chocolate Yule Log.
- Class 14. 5 ginger biscuits decorated with a Christmas theme.
- Class 15. 5 mince pies.
- Class 16. A jar of preserve.

SECTION 4 HANDICRAFT

- Class 17. A hanging Christmas decoration (no fresh flowers). Maximum width 38 cm/15 inches.
- Class 18. Gift tag for a Christmas present using re-purposed materials.
- Class 19. Felt or knitted item with a Christmas theme.

SECTION 5 PHOTOGRAPHY

Prints not to exceed 18 cm x 13 cm / 7" x 5"

- Class 20. "Round the Christmas Tree".
- Class 21. "Winter Walk".
- Class 22. "Exhibitor's Choice."
